2023 CONN NAHRO JOHN J. KELLY MEMORIAL SCHOLARSHIP For Graduating High School Seniors

CONN NAHRO invites graduating high school seniors in Connecticut to apply for one of the available **\$3,500** John J. Kelly Memorial Scholarships for students continuing their education. Annually, three or more scholarships are awarded to students who live in CONN NAHRO member housing authority communities or Section 8 housing who may not be able to take advantage of higher education opportunities due in part to their economic circumstances.

The application process is administered by the CONN NAHRO Scholarship Committee. Recipients are recognized at the Scholarship Luncheon during the CONN NAHRO Annual Convention in August.

Eligibility

- 1) Individuals who have been accepted into a two-year or four-year institution of higher learning working toward an Associate's or Bachelor's degree or a full time Vocational/Certificate program beginning with the Fall term in 2023; and,
- 2) Who reside in, or are assisted with their housing by, a CONN NAHRO member housing authority or agency; and,
- 3) Are residents in good standing.

Criteria

Applicants must meet the following criteria:

- 1) Candidates must be eligible for high school graduation in June 2023 or have already earned their high school diploma or GED in the 2022-2023 academic year.
- 2) Candidates must attain a grade point average (GPA) of at least 2.5 on a 4.0 scale during their four-year high school attendance or, under certain circumstances, a 2.5 GPA on a 4.0 scale during their senior year.

Application

The Scholarship application must be complete and include the following items to be considered:

- 1) Completed John J. Kelly Memorial Scholarship Application Form
- A written recommendation from the Executive Director/CEO or Designee from the applicant's CONN NAHRO member housing authority or community (must be a signed original document or electronic signature).
- 3) The applicant's High School transcript, including SAT or ACT scores if applicable.
- 4) Three (3) additional written letters of recommendation (must be a signed original document or electronic signature).
- 5) A 250 500 word essay on the subject: *How will this scholarship affect me moving forward in life?*
- 6) A list of the applicant's accomplishments, including awards, honors, sports, community service, extracurricular activities, employment, etc.
- 7) A copy of the acceptance letters received from the institutions to which the applicant was accepted.

8) Proof of Financial Aid and any other sources of financial assistance to be received by the applicant (*must be received by June 23, 2023*).

Selection Criteria

The selection criteria is based on a point system for each of the following elements:

30 pointsNeed25 pointsHigh school grades, class rank, and/or SAT/ACT scores20 pointsEssay content20 pointsWork experience, extracurricular activities, and community service.5 points3.0 Grade point average or higher5 pointsNot previously awarded a CONN NAHRO scholarship

Funding

Scholarship awards will be funded by September 1, 2023. CONN NAHRO reserves the right to revoke the scholarship and require repayment of the scholarship if the recipient does not attend the identified educational institution in the Fall of 2023.

Deadline to Apply

Applications must be completed and received by the CONN NAHRO Scholarship Chair no later than **5:00 p.m.** (EDT) on Friday, June 23, 2023. Your Housing Authority Executive Director/CEO will submit the completed application on your behalf.
